**EXECUTIVE ORDER**


WHEREAS Election Commission of India has announced the Poll schedule for Legislative Assembly of Arunachal Pradesh vide its Press Note NO.ECI/PN/47/09 Dtd. 31/08/2009.

AND WHEREAS, consequent upon announcement of Poll schedule, campaign activity is likely to be geared up by contesting candidates of different Political parties which may lead to apprehension of breach of Law & Order situation in the District.

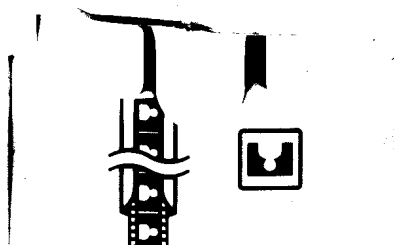
AND WHEREAS, in view of keeping the peace and Public tranquility, it is considered expedient and desirable to prohibit all civil Arms License holders of the district the possession of carrying of the fire arms during the the period of electioneering.

THEREFORE, I, Dr. S.B. Deepak Kumar, IAS, Deputy Commissioner Cum District Magistrate, Changlang District, Changlang, in exercise power conferred under Section 144 (3) Cr.P.C., do hereby direct all civil Arms holders in Changlang District to deposit their respective Arms at the nearest Administrative office/Police Station on or before 29/09/2009, repeat, 29<sup>th</sup> Sept/2009 till Election process is over. Hence, any person found in possession of Fire Arms after 29/09/2009 in violation of this order, shall be liable to punishment under section 188 IPC as well as under relevant section of Arms Act.
